These short-chain carbohydrates are poorly absorbed in the small intestine and rapidly fermented by bacteria in the gut, causing gas and bloating. Individuals who have trouble digesting FODMAPs often have to follow a diet low in FODMAPs, which can be a challenge when trying to eat an array of

Organically grown fruits and vegetables have been found to have higher levels of some beneficial antioxidants, polyphenols and other nutrients than their conventionally grown counterparts.<sup>1,2</sup> In addition, organic agriculture restricts the use of synthetic pesticides, making organically grown produce considerably lower in residual pesticides compared to conventionally grown produce.<sup>3</sup> This product is certified organic and uses all organic fruits and vegetables.

Studies point to a positive correlation between organic food consumption and better health outcomes. Many of these studies conclude it can be difficult to distinguish between the effects of organic food on diet and the overall healthier lifestyle choices organic food consumers typically practice.<sup>4,5</sup>
